Official Rules

1. ELIGIBILITY: The 1-Year Anniversary of Baptist Health IcePlex Giveaway ("<u>Sweepstakes</u>") is sponsored by War Memorial Benefit Corporation ("<u>Sponsor</u>"). The Sweepstakes is open to all legal residents of Florida who are at least 18 years old ("<u>Eligible Person</u>"). Each entrant is responsible for monitoring his/her Instagram account for prize notification and receipt or other communications related to this Sweepstakes. If Winner cannot be reached by the Sponsor within one (1) day or if the Prize is returned as undeliverable, Winner shall forfeit the Prize and such Prize will be awarded to an alternate winner, who will be selected from a random drawing of all remaining eligible entries.
