

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **ELIGIBILITY**: The FTL War Memorial Perfect Date Quiz Giveaway (“Sweepstakes”) is sponsored by War Memorial Benefit Corporation (“Sponsor”). The Sweepstakes is open to all legal residents of Florida over 18 years old (“Eligible Person”). Employees and officers of Sponsor and Sponsor’s parent companies, subsidiaries, affiliates and related entities, advertising agencies, authorized dealers, promotional suppliers, prize providers (each of the aforementioned entities collectively, with Sponsor, the “Sweepstakes Entities”) and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win. 5. The following statement: This card is my entry to The War Memorial Perfect Date Quiz Giveaway.

The Sweepstakes shall commence on June 22, 2026, and the deadline for Sponsor to receive all digital and mailed-in entries for the Sweepstakes is July 22, 2026, at 11:59 PM Eastern Standard Time (“Sweepstakes Time Period”). No entries will be accepted after such time.

3. **ODDS OF WINNER SELECTION AND PRIZE**: Following the conclusion of the Sweepstakes Time Period, Sponsor shall select one (1) Eligible Person (“Winner”) from a random drawing of all eligible entries received during the Sweepstakes Time Period to receive two (2) tickets for seats to be determined by Sponsor in its sole discretion to the Brad Paisley show to take place at the sports and entertainment facility currently known as War Memorial Auditorium on September 18, 2026 and two (2) Baptist Health IcePlex skate passes (“Prize”). The fair market value of the Prize is **\$500.00 USD**. Odds of winning depend on the number of eligible entries received during the Sweepstakes Time Period.

4. **WINNER NOTIFICATION**: Winner shall be contacted on or after July 23, 2026. Instructions for receiving the Prize will be sent to the e-mail address supplied on

entry. Each entrant is responsible for monitoring his/her e-mail account for prize notification and receipt or other communications related to this Sweepstakes. If Winner cannot be reached by the Sponsor within (1) day or if the Prize is returned as undeliverable, Winner may be considered to have forfeited the Prize, and the Prize may be awarded to an alternate winner, who will be selected from a random drawing of all remaining eligible entries. Upon the request of the Sponsor, Winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form, IRS W-9 form, a liability release, and (where legal) a publicity release, all of which must be returned within the time period specified within such materials. Any portion of Prize not accepted by Winner will be awarded to a substitute winner in accordance with Section 4 above. Failure to comply with these Official Rules may result in disqualification. Sponsor reserves the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. 7. **LIMITATIONS OF LIABILITY:** The Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of the Internet, the Application (if applicable), or any combination thereof; or (e) any injury or damage to participant's or to any other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes.
