

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. ELIGIBILITY: The IcePlex Winter Classic Jersey Giveaway (“Sweepstakes”) is sponsored by [War Memorial Benefit Corporation] (“Sponsor”). The Sweepstakes is open to all legal residents of Florida who are at least 18 years old (“Eligible Person”). Employees and officers of Sponsor and Sponsor’s parent companies, subsidiaries, affiliates, and related entities, advertising agencies, authorized dealers, promotional suppliers, prize providers, (each of the aforementioned entities collectively, with Sponsor, the “Sweepstakes Entities”), and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win. Void where prohibited.

2. - c. Phone Number
- d. Date of Birth
- e. The following statement: “This card is my entry to the IcePlex Winter Classic Jersey Giveaway.”

The Sweepstakes shall commence on December 26, 2025, and the deadline for the Baptist Health IcePlex Marketing Department to receive all mailed-in and digital entries for the Sweepstakes is January 2, 2026 at 11:59 PM Eastern Standard Time (“Sweepstakes Time Period”). No entries will be accepted after such time.

3. ODDS OF WINNER SELECTION AND PRIZE: Following the conclusion of the Sweepstakes Time Period, Sponsor shall select one (1) Eligible Person (“Winner”) from a random drawing of all eligible entries received during the Sweepstakes Time Period to each

receive one (1) Winter Classic Jersey to be determined by Sponsor in its sole discretion (“Prize”) to be picked up at the sports and entertainment facility currently known as Baptist Health IcePlex (“Facility”), located at 800 Northeast 8th Street, Fort Lauderdale, Florida 33304. The fair market value of the Prize is \$295.00 USD. Odds of winning depend on the number of eligible entries received during the Sweepstakes Time Period.

4. WINNER NOTIFICATION: Winner shall be notified on or after January 2, 2026. Winner notification and instructions for receiving the Prize will be sent to the e-mail address or phone number supplied on entry. Each entrant is responsible for monitoring his/her e-mail account for prize notification and receipt or other communications related to this Sweepstakes. If Winner cannot be reached by the Sponsor within (1) day or if the Prize is returned as undeliverable, Winner shall forfeit the Prize and the Prize will be awarded to an alternate winner. Upon the request of the Sponsor, Winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form, IRS W-9 form, a liability release, and (where legal) a publicity release, all of which must be returned within the time period specified within such materials. Should the potential winner fail to comply with any such requirements, the potential winner may be disqualified by Sponsor, in Sponsor’s sole discretion, and Sponsor may then select an alternate winner.

Except as determined by the Sponsor in its sole discretion, no substitution of Prize is offered, no transfer of Prize to a third party is permitted, and Prize may not be redeemed for cash value. Winner will be solely responsible for all applicable federal, state and local taxes arising in connection with the Prize. All other expenses on the receipt and use of Prize not specifically mentioned herein are solely the responsibility of the Winner. Any portion of Prize not accepted by Winner will be awarded to a substitute winner in accordance with Section 4 above. In no event will Sponsor be liable to award more than the number of prizes stated in these Official Rules.

6. ACCEPTABLE CONDUCT: By entering this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification. Sponsor reserves the right at its sole discretion to disqualify any individual suspected of tampering with

the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. LIMITATIONS OF LIABILITY: Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of the Internet, the Application (if applicable), or any combination thereof; or (e) any injury or damage to participant's or to any other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes.
